Wahoo, Nebraska

The Council met in regular session and in compliance with agenda posted at City Hall, Post Office and First Bank of Nebraska, with each Council member being notified of agenda prior to the meeting. The meeting was called to order by Mayor Gerald D. Johnson at 7:00 p.m. and opened with the Pledge of Allegiance. The Mayor informed the public of the location of posting of the Open Meetings Law. Roll call was taken with the following Council members present: Mike Lawver, Patrick Nagle, Stuart Krejci, Karen Boop, and Carl Warford. Absent: Greg Kavan.

Department Head written reports were reviewed. Beavers reported on plan reviews and NPZA conference. Street Department is tearing down some buildings at the old facility. Hull reported the department attended the funeral of long-time member Bob Chvatal. Denise Lawver reported the Library is taking measures to sanitize public areas and equipment. Anderson reported the EMS department has been working closely with area agencies to prepare for the coronavirus pandemic, and a county-wide command system has been established. Hurst reported policy changes were approved for new developments, and Board will meet next week.

Conditional Use Permit for Family Child Care Home II at 453 West 4th Street, was reviewed. License is maintained, no issues have been reported. Beavers will check on status of fence. Agreed to schedule review in 24 months.

Ordinance No. 2346 entitled: AN ORDINANCE OF THE CITY OF WAHOO, NEBRASKA, TO AMEND THE OFFICIAL ZONING MAP BY EXTENDING A CONDITIONAL USE PERMIT FOR A FAMILY CHILD CARE HOME II IN R-2 RESIDENTIAL ZONING, was introduced by Warford. The Mayor then instructed the Clerk to read Ordinance No. 2346 of the City of Wahoo, Nebraska. The Clerk thereupon read the aforesaid Ordinance No. 2346 by title.

Council Member Lawver moved that the statutory rules in regarding to the passage and adoption of ordinances be suspended so the said ordinance might be introduced, read by title, and then moved for final passage at the same meeting. Council Member Warford seconded said motion. The Mayor put the question and instructed the Clerk to call for the roll for the vote thereon. Beavers stated he would like to do some additional research on the 2018 International Energy Conservation Code, before the ordinance is adopted.

Motion by Lawver, seconded by Krejci, to approve application for sale of fireworks as submitted by Ka-Boomers Fireworks. Roll call vote: Lawver, yes; Krejci, yes; Boop, yes; Warford, yes; and Nagle, yes. Absent and not voting: Kavan. Motion carried.

Grant Anderson reported on measures being put in place with Three Rivers Public Health, which actually began months ago, which require authorization for his signature on interlocal agreements. Motion by Krejci seconded by Nagle, to approve participation in Interlocal Agreement/Memorandum of

Understanding between Three Rivers Public Health Department and the City of Wahoo Fire/EMS, designating Wahoo Fire/EMS Department as a "Closed POD" distribution point. Roll call vote: Krejci, yes; Nagle, yes; Boop, yes; Warford, yes; and Lawver, yes. Absent and not voting: Kavan. Motion carried.

Motion by Nagle, seconded by Lawver, to approve participation in Interlocal Agreement/Memorandum of Understanding between Three Rivers District Health Department and the City of Wahoo Fire/EMS, designating Wahoo Fire/EMS Department as an assisting agency during a public health emergency. Roll call vote: Nagle, yes; Lawver, yes; Krejci, yes; Boop, yes; and Warford, yes. Absent and not voting: Kavan. Motion carried.

Municipal code amendments regarding tobacco/nicotine products, minor age, and kratom were discussed.

Ordinance No. 2343 entitled: AN ORDINANCE OF THE CITY OF WAHOO, NEBRASKA, TO AMEND THE MUNICIPAL CODE §131.50 AND §131.51 TO PROHIBIT POSSESSION OR DELIVERY OF TOBACCO, VAPOR NICOTINE PRODUCTS, ALTERNATIVE NICOTINE PRODUCTS OR KRATOM BY MINORS AS DEFINED BY NEB. RS 28-1418 AND 28-1419, was introduced by Lawver for second reading. The Mayor then instructed the Clerk to read Ordinance No. 2343 of the City of Wahoo, Nebraska. The Clerk thereupon read the aforesaid Ordinance No. 2343 by title.

Council Member Lawver moved that the statutory rules in regarding to the passage and adoption of ordinances be suspended so the said ordinance might be introduced, read by title, and then moved for final passage at the same meeting. Ordinance No. 2344 entitled: AN ORDINANCE OF THE CITY OF WAHOO, NEBRASKA, TO AMEND THE MUNICIPAL CODE TO DEFINE ALTERNATIVE NICOTINE PRODUCTS, VAPOR NICOTINE PRODUCTS, AND TO PROHIBIT THE USE OF PRODUCTS IN A PLACE OF EMPLOYMENT, A PUBLIC PLACE, OR WITHIN PUBLICLY OWNED PROPERTY, EXCEPT AS DESIGNATED, was introduced by Warford. The Mayor then instructed the Clerk to read Ordinance No. 2344 of the City of Wahoo, Nebraska. The Clerk thereupon read the aforesaid Ordinance No. 2344 by title.

Council Member Warford moved that Ordinance No. 2344 as amended be approved and passed on second reading and its title agreed to. Council Member Nagle seconded the motion.
