The meeting was called to order by Mayor Jerry Johnson at 7:00 p.m. and opened with the Pledge of Allegiance. The Mayor informed the public of the location of posting of the Open Meetings Law. The Mayor was excused from the meeting at 7:00 p.m. Janet Jonas, President of the Council, Acting Mayor, called for items not otherwise listed on the agenda. There were none.

The public hearing regarding amendment of Ordinance 1886 the Wahoo Zoning Ordinance, by amendment of Article 5, Sections 5.07, 5.08, 5.09 an 5.11 regarding setbacks of accessory buildings, and amendment of definitions, was declared open by the Acting Mayor at 7:02 p.m. The Acting Mayor called for questions from the public and none were presented. A motion was made by Lawver, seconded by Krejci, to close the hearing at 7:04 p.m. Roll call vote: Lawver, yes; Krejci, yes; Tyler, yes; Jonas, yes; and Hennings, yes. Svoboda, absent and not voting. Motion carried. This revision will make definitions consistent between the Zoning Regulations and the Subdivision Regulations.

The public hearing regarding amendment of Ordinance 1886 the Wahoo Zoning Ordinance, by amendment of Article 7, Section 7.12.10, pool enclosures, was declared open by the Acting Mayor at 7:05 p.m. The Acting Mayor called for questions from the public and none were presented. A motion was made by Lawver, seconded by Krejci, to close the hearing at 7:06 p.m. Roll call vote: Lawver, yes; Krejci, yes; Tyler, yes; Hennings, yes; and Jonas, yes. Svoboda, absent and not voting. Motion carried. This revision is proposed to make the requirements for protection of swimming pools very clear, and be consistent with the International Residential Code.

The Mayor returned to the meeting at 7:08 p.m.

The Mayor reported he would be asking the Council for a closed session to discuss acquisition of real estate later in the meeting.

The Mayor presented a proclamation declaring October 13, 2012 as Health and Wellness Day in the City of Wahoo.

The Mayor stated he has not been in contact with Skyline Properties, and there is nothing new to report regarding a possible agreement with JEO for additional components of an economic development plan. The Council previously approved participation in a blight study and general redevelopment plan for developable areas along the Highway 77 corridor south of the Highway 92 intersection to a mile south of the golf course. Motion by Tyler to table consideration of this item for discussion at a future meeting. Lawver seconded the motion. Roll call vote: Tyler, yes; Lawver, yes; Hennings, yes; Jonas, yes; and Krejci, yes. Svoboda, absent and not voting. Motion carried.

Curt Bromm, representing St. Wenceslaus Church requested that the Council consider entering into an agreement regarding future closing of 2<sup>nd</sup> Street between Linden and Beech Streets. He stated they need to know if access to 2<sup>nd</sup> Street will be allowed before they can proceed with drawing up plans, arranging for utilities, and obtaining building permits. He suggested the Council could proceed toward closing 2<sup>nd</sup> Street by establishing conditions which would need to be met before the street is closed, similar to those set for the Wahoo Locker expansion, where closing of the street would occur upon proof of commencement of construction. Lindahl discussed the terms of the proposed agreement. A motion was made by Hennings to enter into an agreement with St. Wenceslaus Church regarding future closing of 2<sup>nd</sup> Street, and authorize staff to prepare an ordinance to be presented at the next meeting. Motion seconded by Jonas. Roll call vote: Hennings, yes; Jonas, yes; Lawver, yes; Tyler, yes; and Krejci, yes. Svoboda, absent and not voting. Motion carried.

Jake Vasa of JEO Consulting Group reported on the status of Chestnut Street Improvements. Vasa stated Change Order #4 is mainly due to additional tire and concrete disposal and for quick setting concrete in one area, for an adjustment of \$6,709.60.

Council Member Lawver moved that Change Order No. 4 to the contract with TAB Construction, in the amount of \$6,709.60 for 2012 Chestnut Street Improvements be approved, seconded by Jonas. Roll call vote: Lawver, yes; Jonas, yes; Krejci, yes; Tyler, yes; and Hennings, yes. Svoboda, absent and not voting. Motion carried.

Vasa presented Application for Payment No. 4 to TAB Construction Co. for 2012 Chestnut Street Improvements. Council Member Jonas moved that Application for Payment No. 4 to TAB Construction Co. for 2012 Chestnut Street Improvements, for \$387,514.24 be approved, seconded by Krejci. Roll call vote: Jonas, yes; Krejci, yes; Hennings, yes; Lawver, yes; and Tyler, yes. Svoboda, absent and not voting. Motion carried.

Phil Lorenzen of D. A. Davidson Co. addressed the Council regarding the possible benefits of calling 2007 Various Purpose Bonds. Several alternatives were presented for consideration. A motion was made by

Hennings, seconded by Lawver, to table this resolution to the next meeting. Roll call vote: Hennings, yes; Lawver, yes; Tyler, yes; Krejci, yes; and Jonas, yes. Svoboda, absent and not voting. Motion carried.

Harrell presented the report of the Liberty House Monitoring Committee, recommending continuation of the Conditional Use permit through April 30, 2014, which coincides with renewal of licenses through the State of Nebraska. Additionally, the Committee recommended retaining the conditions that no resident of the facility shall have been convicted of: a felonious offense against a person, an offense involving arson, or a crime listed in Neb. Rev. Stat. §29-4003 which requires registration as a sex offender, and that the facility maintain a license as an Assisted Living Facility with the State of Nebraska.

The settlement agreement with the Lower Platte North Natural Resources District, City of Wahoo and Saunders County were reviewed. The Mayor stated he spoke with Roger Cox of Harding & Shultz, regarding the agreement. Saunders County approved the settlement agreement. A motion was made by Jonas to approve the settlement agreement with the addition of hold harmless language, seconded by Tyler. Roll call vote: Jonas, yes; Tyler, yes; Krejci, yes; Hennings, no; Lawver yes. Svoboda, absent and not voting. Motion carried.

Harrell presented a draft Citizen Participation Plan, which is required when Federal funding is received for projects. Changes were suggested to state, "All meetings will be held at community facilities which are accessible to the handicapped." And "When it is anticipated that non-English speaking persons will participate in the citizen participation process, the City Clerk shall make arrangements for oral or written translation of information regarding any CDBG program, application or project upon request by such non-English speaking persons or representatives of such persons." A motion was made by Lawver to adopt the Citizen Participation Plan with the suggested changes, seconded by Tyler. Roll call vote: Lawver, yes; Tyler, yes; Hennings, yes; Jonas, yes; and Krejci, yes. Harrell requested authorization to draw up minimum specifications, and ask for proposals with detailed information about the equipment available. The proposals received would be reviewed; the City would reserve the right to refuse any proposals. A motion was made by Jonas to authorize development of minimum specifications for a used motor grader, and authorize the Street Committee, Harrell, and Jansa to review proposals received and select the best piece of equipment. Solid waste applications submitted by Waste Connections of NE Inc. and Quality Disposal Service LLC were reviewed. A motion was made by Jonas to accept the applications submitted and approve the permit to haul solid waste for Waste Connections and Quality Disposal. Krejci seconded the motion. Roll call vote: Jonas, yes; Krejci, yes; Tyler, yes; Lawver, yes; and Hennings, yes. Svoboda, absent and not voting. Motion carried.

A motion was made by Lawver, seconded by Tyler, to enter in to closed session to discuss a claim for assessments on Skyline properties, and acquisition of real estate. Roll call vote: Lawver, yes; Tyler, yes; Hennings, yes; Jonas, yes; and Krejci, yes. Svoboda, absent and not voting. Motion carried. The Mayor indicated the Council would be entering into closed session at 8:19 p.m. to discuss a claim for assessments on Skyline properties, and acquisition of real estate.
