Ferrell reported on Police Club and the Little Library interaction with youth. Anderson reported on call volumes, and an invitation to participate in a focus group to represent rural fire and rescue. Building department reported residential projects, Runza, and dirt work beginning for Casey's project. Harrell reported the Airport Authority met, there is a request to expand the main building and still 15-20 names on the hangar waiting list. Staff is dealing with nuisance issues.

Stuhr and Harrell reported on proposed project to complete a press box at Field 1, to be completed before the school season begins. Donation of \$10,000 has been secured; asking for sales tax funding for the balance of the project. A motion was made by Krejci, seconded by Lawver, to approve project to complete a press box on Field 1 at Hackberry Park, using sales tax funds. Conditional Use Permit for automobile service and repair at 859 North Maple Street was reviewed, with recommendation for review in two years.

The Mayor then instructed the Clerk to read Ordinance No. 2312 of the City of Wahoo, Nebraska. The Clerk thereupon read the aforesaid Ordinance No. 2312 by title.

Council Member Lawver moved that the statutory rules in regard to the passage and adoption of ordinances be suspended so the said ordinance might be introduced, read by title, and then moved for final passage at the same meeting. Council Member Boop seconded said motion. The Mayor put the question and instructed the Clerk to call for the roll for the vote thereon. Retention of a general easement for the full area of 14<sup>th</sup> Street right-of-way between Chestnut and Maple Streets was discussed. Ownership of the north and south halves of the vacated right-of-way will transfer to the abutting property on each side. The property owner, KSS Investments LLC, has waived special damages from the vacation, so appointment of committee to determine damages is waived.

**Ordinance No. 2313** entitled: AN ORDINANCE TO VACATE A PORTION OF 14<sup>TH</sup> STREET BETWEEN LOTS 2 AND 3, BLOCK 70, AND LOTS 1 AND 2, BLOCK 87, BOTH IN COUNTY ADDITION, AND RETAIN A GENERAL EASEMENT ON VACATED RIGHT-OF-WAY, was introduced by Krejci. The Mayor then instructed the Clerk to read Ordinance No. 2313 of the City of Wahoo, Nebraska. The Clerk thereupon read the aforesaid Ordinance No. 2313 by title.

Council Member Lawver moved that the statutory rules in regard to the passage and adoption of ordinances be suspended so the said ordinance might be introduced, read by title, and then moved for final passage at the same meeting. Harrell reported two liens/special assessments have been filed against a property known as 740 West 8<sup>th</sup> Street for nuisance abatement totaling \$1,538.29 plus interest, and liens remain unpaid. She requested direction on proceeding to foreclosure, to collect the debt or acquire the property. Motion by Lawver, seconded by Krejci to authorize staff to proceed with foreclosure on property for nonpayment of assessments for abatement of nuisance. Roll call vote: Lawver, yes; Krejci, yes; Boop, yes; Warford, yes; and Tyler, yes. Absent and not voting: Kavan. Motion carried.

Harrell reported on renewal of the Charter Franchise agreement for television service. She asked members to report any issues with Charter, so they may be discussed with a company representative. Charter would like to get the new agreement in place January 1, 2020.

Anderson reported on benefits of membership with Omaha Metropolitan Healthcare Coalition and resources available, at no cost. He reported Wahoo will not be required to respond to disasters or emergency events in the coalition area, but help from our agency may be requested. A motion was made by Krejci, seconded by Boop, to authorize entering into agreement with Omaha Metropolitan Healthcare Coalition. Roll call vote: Krejci, yes; Boop, yes; Warford, yes; Lawver, yes; and Tyler, yes. Absent and not voting: Kavan. Motion carried.

A motion was made by Tyler to enter into closed session for protection of public interest to discuss contract negotiation, with Melissa Harrell, Jovan Lausterer, Lucinda Morrow, Cody Hull, and Grant Anderson to remain in the room, seconded by Krejci. Roll call vote: Tyler, yes; Krejci, yes; Boop, yes; Warford, yes; and Lawver, yes. Absent and not voting: Kavan. The Mayor announced the Council would be entering into closed session to discuss negotiation of a contract with Wahoo Rural Fire District at 8:19 p.m.

A motion was made by Lawver, seconded by Warford to return to regular session at 9:07 p.m. Roll call vote: Lawver, yes; Warford, yes; Tyler, yes; Krejci, yes; and Boop, yes. Absent and not voting: Kavan. Motion carried.
