## **Council Chambers**

## Wahoo, Nebraska

The Council met in regular session in the Wahoo Public Library, 637 Maple Street, in compliance with agenda posted at City Hall, Post Office and First Bank of Nebraska, and the City of Wahoo web site, with each Council member being notified of agenda prior to the meeting. The meeting was called to order by President of the Council Stuart Krejci at 7:00 p.m. and opened with the Pledge of Allegiance. The public was informed of the location of posting of the Open Meetings Law. Roll call was taken with the following Council members present: Ryan Ideus, Chris Rappl, Patrick Nagle, Karen Boop, and Carl Warford. Absent: Mayor Johnson.

Nagle reported the Street Committee met. Ideus reported the Board of Public Works met.

A motion was made by Warford, seconded by Boop to approve the consent agenda, including: 1) Excused absence of Mayor Johnson; 2) Minutes of the February 11, 2021 Council meeting; and 3) minutes of February 4, 2021 Meeting of the Planning Commission. Roll call vote: Warford, yes; Boop, yes; Ideus, yes; Rappl, yes; Krejci, yes; and Nagle, yes. Absent and not voting: none. Motion carried.

The Energy Code remains tabled.

Lausterer reported on the process to obtain a clear title to the property, notification and court proceedings regarding the campus property. Motion by Warford, seconded by Ideus to authorize staff and counsel to proceed with action to obtain clear title to Block 2, Dickensons Addition to Wahoo (Camel Center property). Roll call vote: Warford, yes; Ideus, yes; Rappl, yes; Krejci, yes; and Nagle, yes. Absent and not voting: none. Motion carried.

Dave Henke of JEO provided specifications for dog park fencing, and plans for park development. Fencing was included in City budget, and other improvements will be funded through donations. JEO's services are pro bono. Motion by Nagle, seconded by Rappl, to approve plans and specifications and authorize calling for bids for 2021 Dog Park Fencing Project. Roll call vote: Nagle, yes; Rappl, yes; Boop, yes; Warford, yes; Krejci, yes; and Ideus, yes. Absent and not voting: none. Motion carried.

The Acting Mayor stated the next item on the agenda was second reading, possible waiver of third reading, of Ordinance No. 2365 to amend Municipal Code Title VII: Traffic Code, to provide for removal of vehicles with multiple outstanding parking tickets.

Ordinance No. 2365 entitled: AN ORDINANCE OF THE CITY OF WAHOO, NEBRASKA, TO AMEND THE MUNICIPAL CODE, TITLE VII: TRAFFIC CODE, SECTION 70.04, was introduced by Nagle. The Acting Mayor then instructed the Clerk to read Ordinance No. 2365 of the City of Wahoo, Nebraska. The Clerk thereupon read the aforesaid Ordinance No. 2365 by title.

Council Member Ideus moved that the statutory rules in regard to the passage and adoption of ordinances be suspended so that the said ordinance might be introduced, read by title, and then moved for final passage at the same meeting. Council Member Rappl seconded said motion. The Acting Mayor put the question and instructed the Clerk to call for the roll for the vote thereon. The Clerk called the roll and the following was the vote on the motion to suspend the rules: Roll call vote: Ideus, yes; Rappl, yes; Nagle, yes; Boop, yes; Warford, yes; and Krejci, yes. Absent and not voting: none. Motion carried. The motion having been carried by the affirmative votes of no less than three-fourths of the members of the Council, the Acting Mayor declared the statutory rules in regards to the passage and approval of

ordinance be suspended so that Ordinance No. 2365 may be read by title and moved for final passage in the same meeting.

Council Member Nagle moved that Ordinance No. 2365 be approved and passed and its title agreed to. Council Member Rappl seconded the motion. The Acting Mayor instructed the Clerk to call the roll for the vote and the following was the vote on this motion: Nagle, yes; Rappl, yes; Boop, yes; Warford, no; Krejci, yes; and Ideus, yes. Absent and not voting: none. Motion carried.

The passage and adoption of said Ordinance having been concurred then by a majority of all members of the Council, the Acting Mayor declared the Ordinance adopted and, in the presence of the Council, signed and approved the Ordinance and Clerk attested the passage and approval of the same and affixed signatures thereto. The Acting Mayor ordered the Ordinance to be published in pamphlet form and that said Ordinance be kept in a separate and distinct Ordinance volume record, and that said and distinct Volume be incorporated and made a part of these proceedings the same as though it was read at large herein.

No audience comments. The next meeting date is Thursday, March 11, 2021.
