

The Council met in regular session in the Wahoo Public Library, 637 N Maple, in compliance with the agenda posted at City Hall, Post Office and First Bank of Nebraska, and the City of Wahoo website, with each Council member being notified of the agenda prior to the meeting. The meeting was called to order by Mayor Gerald D. Johnson at 7:00 p.m. and opened with the Pledge of Allegiance. The public was informed of the location of posting of the Open Meetings Law. Roll call was taken with the following Council members present: Stuart Krejci, Ryan Ideus, Chris Rappl, Karen Boop and Patrick Nagle. Council Members absent: Carl Warford

Denise Lawver, Library Director, gave the annual library report. Numbers indicate that the Library is seeing a turn around from the lower numbers seen during 2020-2021 due to COVID. The Wahoo Library turns 100 in 2023 and there are plans to make it a big year for the Library.

Council Member Krejci motioned, and Council Memembr Ideus seconded to approve the consent agenda which includes acceptance of excused absence of Council member, approval of minutes from the November 8th, 2022, City Council Meeting, approval of Todd Coffey as a new part-time paramedic, approval of Pay App No 12 to M.E. Collins in the amount of \$34,059.89 for the North Highlands project approval of amended drawdown #10 from SENDD in the amount of \$22,163.19 to Roofia, \$32,972.38 to Goundworks and 13,362.00 to Veskerna Plumbing. Roll call vote Krejci, yes; Ideus, yes; Boop, yes; Rappl, yes; Nagle, yes; Warford, absent and not voting. Motion carried.

Craig Breunig and John Smaus from the Saunders County Board of Supervisors presented regarding a plan for a new radio tower to be placed in or around Wahoo. This tower would be an update to the current 911 system in place in the county. Wahoo is centrally located within the county making it an ideal location for placement of a new tower. It would need to be approximately 300 ft, which restricts where it could be built. This is in the early stage of planning, but they will need to work with the city to find an ideal location for its placement.

A public hearing regarding street improvement district 2022-01 for Wilmer Ridge Subdivision was opened at 7:31pm. There were no comments from the public. Council Member Krejci motioned, and Council Member Nagel seconded to close the public meeting at 7:33pm. Roll call vote Krejci, yes; Nagle, yes; Boop, yes; Ideus, yes; Rappl, yes; and Warford, absent and not voting. Motion carried.

Council Member Krejci motioned, and Council Member Ideus seconded to approve resolution 2022-23 acknowledging no remonstrances against street improvement district 2022-01. Roll call vote Krejci, yes; Ideus, yes; Boop, yes; Rappl, yes; Nagle, yes; Warford, absent and not voting. Motion carried.

A public hearing regarding the Resolution of Necessity for storm and sanitary improvement districts was opened at 7:33pm. There were no comments from the public. Council Member Krejci motioned, and Council Member Ideus seconded to close the public hearing at 7:34pm.

Krejci, yes; Ideus, yes; Boop, yes; Rappl, yes; Nagle, yes; Warford, absent and not voting. Motion carried.

Concerns were expressed by the Council regarding the exchange of retail space for parking. There was also talk regarding what number of retail spaces would be adequate for the council to approve the project.
