The Board would like to schedule a joint meeting with the Council members to discuss all possibilities in regards to the RICE issue. A date has not been set yet.

Jim reported the Butler County Rural Electric has not contacted him in regards to the annexation Power Review Board application to change service area boundaries. All information has been forwarded to the City Attorney.

Dave Henke recommended that the bid of K2 Construction in the amount of \$92,000.00 for the effluent pump be recommended to the City Council for approval. <b>§50.076 Foreclosure Property Service Fees</b> Temporary Electrical Services provided at a Flat Fee of \$50 for only 48 hours of Service. The Application Form for Services at Wahoo Utilities would have to be completed with payment before connecting only Electrical Services. This would NOT include any Natural Gas or Water Services. Penalty for Tampering with the Meters in §50.01 and §50.02
3. That this Amendment shall be effective upon its date of adoption by the Board of Public Works of the City of Wahoo, Nebraska.
4. That the Utilities General Manager of the Wahoo Board of Public Works, and the appropriate staff, be authorized to implement this Amendment.
5. That this Amendment shall be added to and made a part of the Wahoo Board of Public Works Code Book upon its approval and adoption.

Dave Henke with JEO Consulting Group presented a Report on the Maple Street Sewer Relief Trunk – 40% of project is complete and weather permitting Collin's will continue working.

Dave also reported that the effluent pump has been ordered and as soon as the pump is in then they will have a pre-construction meeting.

Merle Hennings made the motion to approve Pay Application #2 to ME Collin's in the amount of \$104,241.94. Motion was seconded by Forbes. All ayes. Opposed: none. Motion carried.

Jim reviewed the insurance coverage and values of the utilities properties and informed them the there would be no changes to the value of any equipment or property due to the decrease in premiums from LARM, our insurance Company.

Carrie presented the Board with the write off of bad debts for 2011 in the amount of \$5,814.54 (Electric \$2,645.68; Water, \$326.99; Gas, \$1,551.29; Sewer \$682.34, Elect, Penalties, \$450.53; and Gas Penalties \$157.69). The motion to approve 2011 Bad Debt Write Offs was made by Hennings and seconded by Forbes. All ayes. Opposed: none. Motion carried.
