Council Chamber Wahoo, Nebraska January 8, 2018

The Wahoo Board of Public Works met in Special Session on January 8, 2018 in accordance with agenda posted at City Hall, Post Office, and First Bank of Nebraska with each board member being notified of the agenda prior to the meeting. Meeting was called to order by Chairman Al Grandgenett at 8:15 a.m. with the following board members present answering to roll call: Gerry Tyler, and Corky Forbes. Greg Kavan and Joel Woita were absent.

Gibney indicated the purpose of the special meeting was to discuss the impact of the recent spikes in natural gas rates on the open spot market, to report how these rates impacted the purchasing of natural gas, and to determine how these impacts should be mitigated with the users/rate payers in Wahoo.

Discussion was held on the situations leading to the spike in spot market gas rates, including declaration of "critical days" by the pipeline owner, the extreme cold weather across the entire nation, and the impact of the market speculators. Explanation was offered on the ways natural gas is purchased by Wahoo Utilities and the positive impact the diversification of purchasing had on this situation for Wahoo rate payers.

Gibney explained under the current rate structure, the entire price of the gas purchased would be passed directly on to the customer through the PGA rate calculation that is described in the rate ordinance passed by the Council, which changes each month to provide the adjustment for the cost of purchasing natural gas. Discussion was held on whether this should be subsidized by the use of cash reserves collected from natural gas rate payers. Concern was briefly expressed about showing favorable consideration to the natural gas rate payers over electric rate payers (since both experienced the extreme cold weather conditions), but it was agreed this was not an issue as the market fluctuation did not happen with electricity rates; it was only changes caused by cold weather, which also impacted natural gas rate payers.

Forbes expressed concern about the impact and hit to commercial rate payers, and Tyler expressed support for use of cash reserve to help subsidize the cost increase of gas caused by the spot market rates.

A motion was made by Tyler to apply \$100,000 of cash reserve from the natural gas fund to the bill to Clayton Energy for the month of December, and to bill the balance of the costs to the customers as provided in the rate ordinance. Motion seconded by Forbes. Roll call vote: Tyler, yes; Forbes, yes; and Grandgenett, yes. Kavan and Woita, absent and not voting. Motion carried.

It was discussed all eligible customers should be re-notified of the option for the level payment plan option. In addition, Gibney discussed the possibility of contractual agreements with commercial customers when necessary.

On a motion by Tyler and seconded by Forbes, the Board adjourned at 8:54 a.m.

AMENDMENT NO. 2018-01 TO WAHOO BOARD OF PUBLIC WORKS CODE BOOK

WHEREAS, pursuant to Ordinance No. 1815 of the City of Wahoo, Nebraska, adopted October 14, 2002, the Mayor and Council of the City of Wahoo, Nebraska, did create a Board of Public Works for the City of Wahoo, Nebraska, pertaining to the utilities of the City of Wahoo, Nebraska, including, but not limited to, the electric utility, natural gas utility, water utility, and sewer utility, and,

WHEREAS, pursuant to said Ordinance, the Mayor and Council of the City of Wahoo, Nebraska, did appoint a Board of Public Works to govern said utilities except for those matters relating to utility rate setting, and,

WHEREAS, pursuant to said aforenoted Ordinance, all applicable portions of the Wahoo Municipal Code of the City of Wahoo, Nebraska, pertaining to utilities, except for those matters relating to utility rate setting, were transferred to the Board of Public Works, including the penalty provision therein, and,

WHEREAS, the Board of Public Works has codified said transferred portions of the Wahoo Municipal Code into the Wahoo Board of Public Works Code Book, and,

WHEREAS, Chapter 50 thereof pertains to Utilities General Provision, and,

WHEREAS, the Board of Public Works of the City of Wahoo, Nebraska, deems it in the best interest of the citizens and rate payers of the City of Wahoo, Nebraska, that there be an amendment to Section 50.20 of the Wahoo Board of Public Works Code Book pertaining to Use of Utility Property and Equipment and Equipment Rental Rates, and,

WHEREAS, pursuant to a motion duly enacted by the Board of Public Works at a meeting thereof on December 19, 2018, this aforenoted Amendment has been reviewed by legal counsel for the Board of Public Works and the Mayor and Council of the City of Wahoo, Nebraska, will be notified of this Amendment,

NOW, THEREFORE, IT IS HEREBY RESOLVED by the Board of Public Works of the City of Wahoo, Nebraska, as follows:

- 1. That the findings here and above made should be and are hereby incorporated herein by reference as fully as if set out at length herein.
- 2. That Section 50.20 of the Wahoo Board of Public Works Code Book pertaining to Use of Utility Property and Equipment and Equipment Rental Rates is hereby amended as follows:

§50.20 Use of Utility Property and Equipment and Equipment Rental Rates

No utility equipment, material, tools or supplies shall be used for personal benefit without prior approval of the Utilities General Manager. Use of equipment or tools by employees shall be restricted to:

(A) Personal use not resulting in monetary gains

- Occasional events
- After regular work hours (C)

Employees shall be qualified to operate the equipment and shall pay the standard rate for use of the equipment, tool

or supplies. Repeated use of equipment by an employee shall not be permitted.

If contractors (for work inside city service limits) or residents of the city have special needs they may rent utility equipment or tools with a qualified utility operator. Time of use shall be after regular working hours.

Repeated use of equipment shall not be permitted. In all cases the employee shall be on overtime pay and shall ONLY operate the equipment and shall NOT assist with other work. The requesting person or employee shall pay full labor cost and equipment rental fees.

Equipment rental rates are as follows:
