### AMENDMENT NO. 2020-01 TO WAHOO BOARD OF PUBLIC WORKS CODE BOOK

WHEREAS, pursuant to Ordinance No. 1815 of the City of Wahoo, Nebraska, adopted October 14, 2002, the Mayor and Council of the City of Wahoo, Nebraska, did create a Board of Public Works for the City of Wahoo, Nebraska, pertaining to the utilities of the City of Wahoo, Nebraska, including, but not limited to, the electric utility, natural gas utility, water utility, and sewer utility, and,

WHEREAS, pursuant to said Ordinance, the Mayor and Council of the City of Wahoo, Nebraska, did appoint a Board of Public Works to govern said utilities except for those matters relating to utility rate setting, and,

WHEREAS, pursuant to said aforenoted Ordinance, all applicable portions of the Wahoo Municipal Code of the City of Wahoo, Nebraska, pertaining to utilities, except for those matters relating to utility rate setting, were transferred to the Board of Public Works, including the penalty provision therein, and,

WHEREAS, the Board of Public Works has codified said transferred portions of the Wahoo Municipal Code into the Wahoo Board of Public Works Code Book, and,

WHEREAS, Chapter 50 thereof pertains to Utilities General Provision, and,

WHEREAS, the Board of Public Works of the City of Wahoo, Nebraska, deems it in the best interest of the citizens and rate payers of the City of Wahoo, Nebraska, that there be an amendment to Section 50.19 of the Wahoo Board of Public Works Code Book pertaining to Impact Fees, and,

WHEREAS, pursuant to a motion duly enacted by the Board of Public Works at a meeting thereof on February 17, 2021, this aforenoted Amendment has been reviewed by legal counsel for the Board of Public Works and the Mayor and Council of the City of Wahoo, Nebraska, will be notified of this Amendment,

NOW, THEREFORE, IT IS HEREBY RESOLVED by the Board of Public Works of the City of Wahoo, Nebraska, as follows:

1. That the findings here and above made should be and are hereby incorporated herein by reference as fully as if set out at length herein.

2. That Section 50.19 of the Wahoo Board of Public Works Code Book pertaining to Impact Fees is hereby amended as follows:

#### §50.19 Impact Fee

The Customer shall pay a fee to the Utilities to compensate for the cost of new individual services and to pay for facilities utilized.

(A) The Utility Board shall establish charges based on the cost to provide individual services to the consumer.

(1) Electric: 120/240V 200Amps or less \$500, 32Amps: \$600, 400Amps: \$800, 3 phase by arrangement.

(1) Electric: Small Lot Residential (100, 125, 200 amp) \$ 950.00

Small Lot Residential (320 amp) \$1,100.00

Large Lot Residential (200, 320 amp) \$1,350.00

Residential 400 amp services are no longer allowed.

Commercial and Industrial services will be charged the associated costs for the service.

### Lot size is based on zoning definitions.

(2)Water: ¾ inch service \$525, 1 inch service \$575, anything larger will have to be by special arrangement.

(2) <u>Water: 1" water service</u> \$1,350.00

All water services larger than 1" will be installed on a time and material basis.

(3) Sewer: Single family \$750, Multi-family \$500 for 1<sup>st</sup> unit, plus \$350 for each additional unit, Mobile home lots \$500 per lot, Industrial or commercial lots maximum \$3,500 per acre, but not less than \$750 per acre.

(4) Natural Gas: \$500 Residential lot, Commercial applications are by special arraignment.

(4) Natural Gas: Residential \$1,200.00

Commercial & Industrial will be charged the associated costs for the service.

3. That this Amendment shall be effective upon its date of adoption by the Board of Public Works of the City of Wahoo, Nebraska.

4. That the Utilities General Manager of the Wahoo Board of Public Works, and the appropriate staff, be authorized to implement this Amendment.

5. That this Amendment shall be added to and made a part of the Wahoo Board of Public Works Code Book effective April 1 , 2021

The Wahoo Board of Public Works met in Special Session on March 3, 2021 in accordance with agenda posted at City Hall, Post Office, and First Bank of Nebraska with each board member being notified of the agenda prior to the meeting. The Chairman informed the public of the location of posting of the Open Meetings Law. Meeting was called to order by Chairman Al Grandgenett at 5:00 p.m. with the following board members present answering to roll call: Al Grandgenett, Joel Woita, Ryan Ideus, Corky Forbes, Gerry Tyler, and Melissa Harrell.

The Board of Public works met in Special Session to discuss the financial impact and options of recovery for the 5 day Natural Gas spike, February 13, 2021 thru February 17, 2021. Three recovery option were presented to the Board for their consideration and each option had different dollar amounts allocated from the gas fund cash reserve.

Option 1: This option would lower the impact to customers using an amount determined by the Board and then bill the customer a one-time bill based on usage to include the 5 days in February and the adjusted PGA charge. Advantages to this option are that the customer would know exactly what the cost of this event was, allow those

customers who chose, to make a one-time payment; assistance is available, if the customer qualifies and, customers could choose a level payment plan to spread the payment out until December of 2021.

Option 2: This option would again be adjusted by whatever amount the Board determined to use from the gas fund cash reserves and then the Utilities would determine the adder that would be needed to collect the remaining funds from this event. This would then be added on to their monthly bill (based on usage), until the funds were collected. Based on average usage this would take about a year to collect.

Option 3:This option again would be adjusted by whatever amount the Board determined to use from the gas fund cash reserves. The remain amount would be a flat dollar amount added to each customers bill in order to recover the funds within a year. This amount would not be based on usage as it would be just a flat fee for everyone.

Gerry Tyler made the motion to use \$200,00.00 from the gas fund cash reserves to help off set the impact of the gas spike costs. The motion was seconded by Forbes. Roll call vote: Tyler, yes; Forbes, yes; Grandgenett, yes; Woita, yes and Ideus, yes. Motion carried.

Ryan Ideus made the motion that Option 1 should be used to recover the cost of the gas bill due to the cold weather and gas spike, He felt that this option allowed the customer the most flexibility. Motion was seconded by Forbes. Roll call vote: Ideus, yes; Forbes, yes; Tyler, yes; Grandgenett, yes and Woita, yes. Motion carried.

Items readily removable shall not be included in the cost calculations of the electric system. The Utility Board or its designated agent shall establish charge. Credits may be available if the requested service meets specified conditions.

<u>All fees are based on the development being within 300 feet of a primary power circuit and natural gas piping</u> capable of handling the size of the development. Any major upgrades beyond that would be negotiated on a case-by-case bases.

For R1 residential (small lot/single family lot developments)\$750.00/lotfor infrastructure\$750.00/lot

For R2 low to medium density homes such as duplexes and multi-family\$500.00/lot/unitFor R3 higher density/multi-family development, we will evaluate on a case-by-case basis.

Large Lot Residential outside city limits \$1,000.00/lot

All commercial developments and upgrades will be evaluated on a case-by-case basis, the guiding policy will be based on the Return of Investment. For new businesses to town the Return of Investment will be 12-24 months. For existing business upgrades on established businesses with 5 or more years of service history, a 24-26 month on Return of Investment will be used. The Board of Public Works reserves the right to require a shorter or longer Return of Investment depending on the risk to the Wahoo Utilities.

## **Natural Gas Developer Fees:**

For **R1** residential (small lot/single family) and R2 residential (low to medium density/duplexes and multi-family)
\$200.00/lot or unit

For **R3** higher density/multi-family development, we will evaluate on a case-by-case basis. Because this type of development can vary greatly, we will treat this style of development like commercial or R@ depending on the development.

Large Lot Residential outside city limits \$400.00/lot

All commercial developments and upgrades will be evaluated on a case-by-case basis, the guiding policy will be based on the Return of Investment. For new businesses to town the Return of Investment will be 12-24 months. For existing business upgrades on established businesses with 5 or more years of service history, a 24-26 month on Return of Investment will be used. The Board of Public Works reserves the right to require a shorter or longer Return of Investment depending on the risk to the Wahoo Utilities.

## Water and Wastewater Developer fees:

On all new developments, it is the preference of the Board of Public Works that the water and wastewater infrastructures be installed and paid for by the developer. The water and wastewater must meet the specifications of the City of Wahoo. If the developer chooses to have the City of Wahoo/Wahoo Utilities install the water and wastewater infrastructure, all costs are subject to a development fee.

Improvements to existing infrastructure to meet the needs of the developer will be subject to review by the Board of Public Works for any fees to be assessed. It is the practice that a per acre fee will be assessed based on improvements that can be readily shown to be beneficial to future developments beyond the proposed development. All Commercial improvements will be treated like residential improvements with the added component of impact on our water production and wastewater treatment capabilities. Costs associated with improvements needed or added pretreatment monitoring will be passed to the development at the discretion of the Board of Public Works.

All new developments must follow Article 7 of the City of Wahoo Subdivision Regulations and must be constructed to meet City of Wahoo Infrastructure Standards.

### §52.08 Residential Drops

- The City of Wahoo Utilities requires all residential overhead services that are being repaired or upgraded to be served by an underground drop, unless it is determined by the Utilities General Manager, to be unreasonable to do so.
- When the service size is not increased, the customer is required to pay the utility expenses for the service modifications. On underground services, the utility will trench, install, and connect the new cable at the

owner's expense. The customer may elect to provide the trench. Stripping of sod, backfilling, and tamping of the ditch are the owner's responsibility.

If an existing service is increased in ampacity, the customer shall be responsible for the cost of the meter socket. In lieu of the replacing the overhead drop, the utility shall install the new underground drop at no charge.

The fee to convert utility service from overhead to underground will be \$500.00. This will include the meter socket and all materials and labor for the service installation. The homeowner is responsible for all work done on/in the home and the installation of the meter socket. This is always done by a licensed electrician.
