WAHOO MUNICIPAL AIRPORT

The Wahoo Municipal Airport is a publicly owned facility which is located just two miles north and east of the city at the intersection of Highways 77/92 and 109, at the northeast edge of Wahoo. The airport is owned and managed by the Wahoo Airport Authority, which is a five-member body. The airport authority recently completed a \$2 million Improvements in recent years include paved runway extension, aircraft parking area, and full length taxiway project, new six-place t-hangar, lighted windcone and segmented circle, ADS-B radio site, and AWOS-III. A Jet-A fuel system is planned. There are 48 aircraft currently based in hangars at the airport. The paved runway is 4,100 feet long and has all weather instrument approaches. The Wahoo Airport features a pilot's lounge, courtesy car, full service major repairs, 100 LL 24-hour credit card fuel service, and overnight hangar space.

AP-Airport Protection Area

This area covers an area similar to existing airport zoning and accommodates future expansion projects that have been identified by the Wahoo Airport in their Airport Layout Plan (ALP). In addition, Federal Aviation Administration (FAA)regulations and Neb. Rev. Stat.§3-301 to 3-333, provide that local zoning authorities enact regulations to protect airport hazard areas three miles from the adjacent boundary of an airport. The AP-Airport Protection Area shall include area as depicted in the Nebraska Department of Aeronautics (NDA) zoning map for Wahoo Municipal Airport which falls within the zoning authority of the City of Wahoo, .
