ATTACH FENCE SITE PLAN - ALL WORK IS SUBJECT TO INSPECTION

Prior to beginning any work on a building or remodeling project in the City of Wahoo, you should check to see if it is permitted under Building Code and Zoning Regulations. Information is available at City Hall, 605 North Broadway, Wahoo, NE, and on the City of Wahoo website, www.wahoo.ne.us, Building Inspection and Planning and Zoning sections. Electric, gas, and water meters must be accessible to Wahoo Utilities for maintenance and meter readings at all times.

This permit shall be maintained available until final approval has been granted by the building official. THE PERSON DOING THE WORK shall notify the building official that such work is ready for inspection. 24 hour advance notice is requested (call 402-443-3222 to arrange an appointment)

Except where an extension has been obtained in writing from the Building Inspector, permits issued shall expire within ninety (90) days if the work described in the permit has not begun or the use applied for has not been established and within one year if the work has not been completed.
