Building Maintenance

Repair work included the Civic Center hot water heating element, patching plaster wall at Civic Center, replacing ceiling tiles at Senior Center, and spraying sidewalks at Civic Center, City Hall, and Library.

Parks

The Aquatic Center closed for the abbreviated summer season on August 9th. Preparations for winterizing began immediately and included draining the pool, taking down shade structures and diving boards, and draining indoor plumbing fixtures. Several larger projects at the pool also began including the removal and rebuilding of one of the pump motors as well as the painting of the gutters. Similarly, with all baseball activity done for the season at Crawford, staff spent time breaking down that facility. Vehicle and equipment repair work included a new water pump in a pickup and new solenoid switch in the Kubota mower.

The high school softball season began at Hackberry Park with practices early in the month and games beginning on August 24th. Two new speakers were installed on the Field #1 press box. Routine maintenance included mowing, trimming, weeding, and spraying the parks and trails.

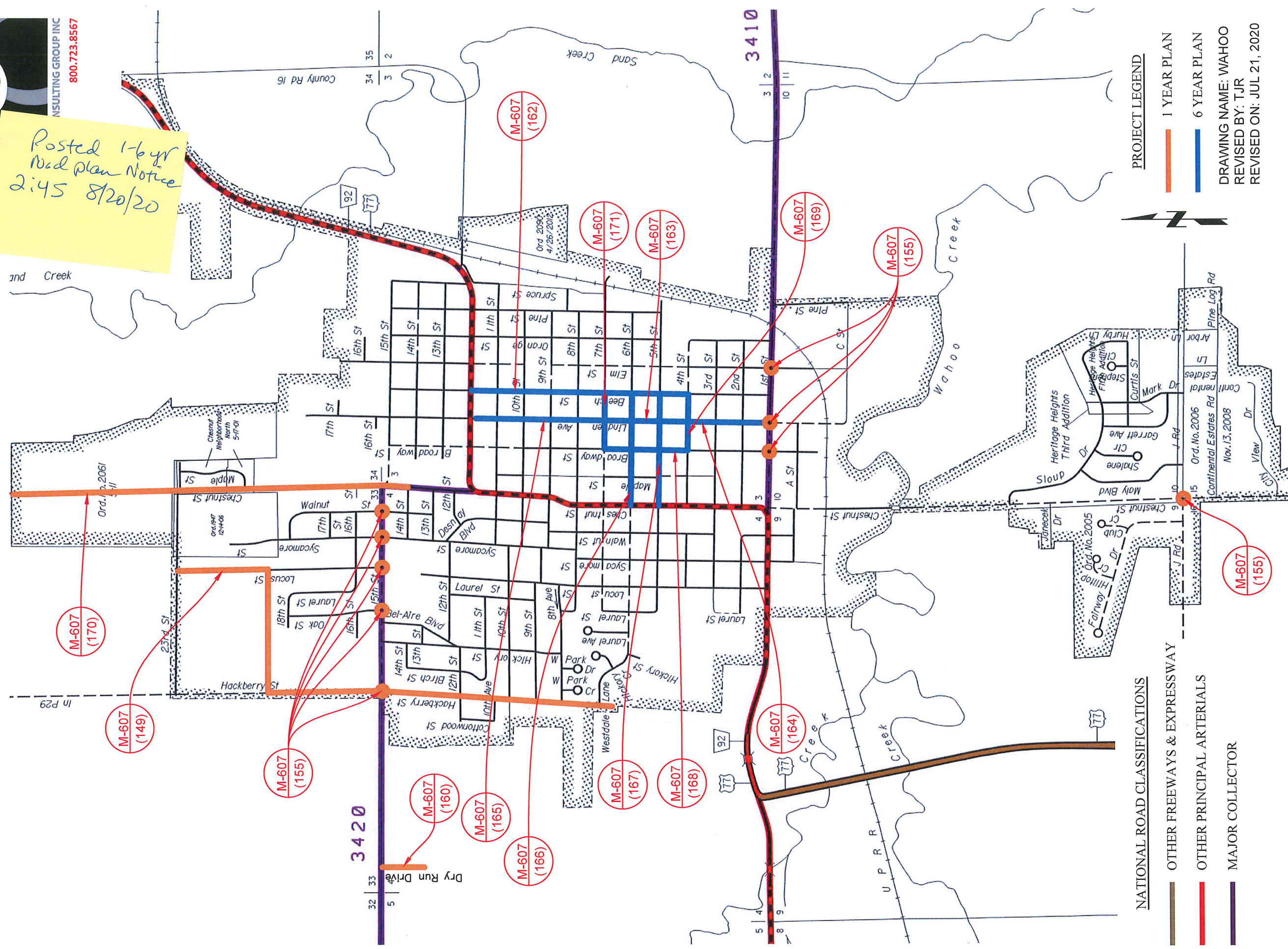
